### ADR 790: ETHICAL AND PROFESSIONAL IMPLICATIONS OF ADR

This course provides participants with a structured practicum opportunity to integrate ADR theories, skills, and techniques garnered from each candidate's previous course of study. Ample class time will be set aside for a "clinic" where participants examine actual ADR case situations and devise, critique, and apply ethical, effective dispute resolution strategies. Codes of ethics for neutrals, and the movement towards uniform qualifications for ADR professionals will also be reviewed. Special attention will be given to problem solving theory and the characteristics of effective neutrals. ADR 790 has been scheduled as follows:
